



# VENDOR APPLICATION FOR THE SOUTHEAST POLICE MOTORCYCLE RODEO

An event benefiting Concerns of Police Survivors (C.O.P.S.)

## DATE, TIME & LOCATION

The Southeast Police Motorcycle Rodeo will be held on Saturday, April 20<sup>th</sup>, 2024, at the Pompano Beach Citi Centre, from 8 am – 4 pm. The Pompano Beach Citi Centre is located in Pompano Beach, Florida at 1955 Federal Highway.

## VENDOR FEES

The Food & Vendor participation fee is \$100 - payable by check to the Southeast Police Motorcycle Rodeo, and due with a completed application no later than April 10, 2024. No checks will be cashed until the vendor acceptance process is complete. The Southeast Police Motorcycle Rodeo Committee will return checks to applicants not chosen for the event. The \$100 fee is **non-refundable\*** upon a vendor's selection.

\*A formal request can be made to the Board for refunds based on special circumstances.

Preference will be given to vendors who have products or services that relate to the police motorcycle officer, police work in general, and motorcycling in general. Others will be considered if space is available.

## TENTS & DISPLAY REQUIREMENTS

Each Vendor must supply:

- Tablecloth/covering for all tables in their booth;
- A 10' x 10' professional style canopy, if desired;
- Tables or displays;
- Professional signage displaying their business name.

Locations will be assigned by The Southeast Police Motorcycle Rodeo

**There will be a Vendor Fee of \$150 if a trailer is required.**

## SET UP, BREAK DOWN & CLEAN UP

Set up will begin at or before 6:30 a.m. sharp on the day of the event and must be completed by 7:30 a.m. Break down will begin at 3:00 p.m. **NO early break down will be allowed.** Vendors are

responsible for ALL trash removal from their space. Trash and recyclables must be disposed of in the designated areas. If desired, the set-up of space may take place the day before the event, between 9 am – 3 pm.

### **VEHICLES**

Vehicles are only allowed during set-up time. All vehicles must be moved before 7:30 a.m. on the event date. (Parking area will be provided near the vendor booths).

### **CANCELLATION POLICY**

The Southeast Police Motorcycle Rodeo will be held on April 20<sup>th</sup>, 2024. There will be no refunds. Any Vendor who has reserved space but is unable to attend the event **MUST** notify the Southeast Police Motorcycle Rodeo no later than 5 pm on April 10<sup>th</sup>, 2024.

### **SELECTION PROCESS**

Submission of an application does not imply or guarantee acceptance as a 2024 Southeast Police Motorcycle Rodeo vendor. After all applications have been turned in, prospective vendors will be evaluated and contacted. Vendors will be selected based on the quality of products/services provided, and relevance to the event's theme.

## **VENDOR/EXHIBITOR RULES, REGULATIONS, TERMS & CONDITIONS**

1. Vendors must provide a sample, photograph, and/or link to a Web site representing the items/services they intend to sell/promote.
2. The Southeast Police Motorcycle Committee will assign vendor slots.... No substitutions will be allowed.
3. **Vendor fees are non-refundable (within 7 days).**
4. A Vendor slot consists of one 10' x 10' space. Each vendor is responsible for bringing and providing any other necessary equipment and supplies to do business at the event. The Southeast Police Motorcycle Rodeo does not loan, rent, or in any way supply vendors with additional equipment.
5. Vendors must provide their table covering. All booth tables MUST be covered.
6. All Vendors must display professional signage at each selling space identifying the business name. Signage must remain within the limits of the Vendor selling space.
7. All Vendor activities must be confined to the allotted space. Contiguous slots are available.
8. The consumption of alcohol on premises by Vendors is not allowed.
9. Vendors are responsible for the collection of their own sales tax and event liability insurance.
10. Each Vendor is responsible for his/her booth and all items in it.
11. No setup will be allowed before 6 a.m. on April 21<sup>st</sup>. No material may be left in the lot the night before or after the event.
12. Booths must be ready to open by 8:00 a.m. and remain open until 4:00 p.m.
13. Food items and beverages CANNOT be sold or given away by a non-food vendor unless the Southeast Police Motorcycle Rodeo provides permission, and it doesn't affect the food vendors at the event.
14. Vendor recycling is expected, and containers will be provided.
15. Smoking is not permitted in Vendor booths.
16. Vendors must comply with the rules & regulations of the Southeast Police Motorcycle Rodeo, Pompano Citi Centre, The City of Pompano Beach, and Broward County, Florida.
17. Rules may be subject to change without advance notice.
18. The Southeast Police Motorcycle Rodeo reserves the right to assign, limit the quantity of or relocate space(s) rented by a Vendor. The sharing or subletting of booths is not permitted.
19. The vendor will provide a copy of event liability insurance, naming the Southeast Police Motorcycle Rodeo Committee, Inc., and the Pompano Beach Citi Centre as additional insured.
20. If food sales are part of the booth, the Vendor must pass state health inspection and provide any fees state health inspector's levy.
